# STOCK RECOMMENDATION - NOVEMBER 29TH, 2021

#### MARKET REVIEW

#### For the week ended November 26, 2021.

- The Nigerian equities market ended the previous week on a positive note as the All-share Index improved by 0.25% WoW to close at 43,308.29pts. Thus, the Year-to-Date return improved to +7.54%.
- On a sectoral basis, performance was mixed across the various indices as NGXOILGAS (-0.9% WoW), NGXBNK (-0.3% WoW), NGXINDUSTR (-0.03% WoW) and NGXCNSMRGDS (-2.00% WoW) all closed in the red, while NGXINS (+3.56% WoW) closed in the green.
- UPL (+27.83% WoW) topped the gainers' chart, while AIICO (-46.15% WoW) was the week's top loser.

# MARKET PREVIEW

#### For the week commencing November 29, 2021.

- The mood in the market was largely mixed last week, the price appreciation on bellwether stocks towards the end of the week however pushed the market to the positive close.
- As per the most recent FPI report by NGX, foreign interest in the local bourse improved by 74.21% to NGN42.42bn (vs NGN24.35bn in September 2021). However, foreign participation declined from 20.16% to 19.91% in October 2021.
- Barring any significant movement on bellwether stocks, we expect the market to close in the negative as the overriding sentiment is expected to be negative this week.
- We therefore expect the market to close the week on a negative note as the sentiment remains largely bearish.
