STOCK RECOMMENDATION - SEPTEMBER 26TH, 2022

MARKET REVIEW

For the week ended September 23rd, 2022.

- The Nigerian equities market ended the week on a negative note, as the All-Share Index declined by 0.91% WoW to close at 49,026.62pts. Consequently, the Year-to-Date return decreased to 14.77% (from 15.82% the prior week).
- Across sectors, performance was broadly negative, as all sectoral indices except NGXBNK recorded week-on-week losses.
- The top gainer for the week was VITAFOAM (+12.25% WoW), while NGXGROUP (-13.92% WoW) was the week's top loser. ZENITHBANK and MTNN topped the activities chart as the most traded stocks by volume and value, respectively.

MARKET PREVIEW

For the week commencing September 26th, 2022.

- We expect the bearish sentiment in the equities market to persist this week, due to investors' preference for fixed income investments.
- The forthcoming Treasury bills Primary Market Auction as well as the outcome of the Monetary Policy Committee meeting this week are also likely to suppress buying activities in the equities market.
- While coupon payment of c. NGN131bn is expected to increase system liquidity this week, the scheduled T-bills auction might leave the effect on equities muted.
- Overall, we expect the market to close in the negative zone.

Target Price Estimate

While we believe that the fair value is underpinned by the future benefits stream and growth outlooks, which are primary drivers of value, the market might not align to the fair value estimate within the estimated investment horizon. Thus, we do not derive our target price from the fair value but from a trading perspective using the year projected earnings or book value and the respective target multiples. Notwithstanding, we are of the opinion that the variance between the two should not be too significant.
