

Market Review

For the week ended March 10th, 2023

- The Nigerian Equities Market closed in the green zone last week, with the All-Share Index gaining 0.48% to end the week at 55,794.51 points. As a result, the Year-to-Date improved to 8.87% from 8.35% the week before.
- Performance was mixed across sectors, with losses recorded by NGXOILGAS (-3.82% WoW), NGXBNK (-1.82% WoW), MERI-TELCO (-0.30% WoW)and NGXCNSMRGDS (-0.26% WoW), while gains were reported by NGXINS (+0.70% WoW), NGXINDUSTR (+1.71% WoW) and MERI-AGRIC (+0.87% WoW).
- JBERGER was the top gainer for the week (+10.00% WoW), while MRS was at the top of the losers' list (-18.99% WoW). The most actively traded equities by volume and value were TRANSCORP and BUACEMENT, respectively.

Market Preview

For the week commencing March 13th, 2023

- We posit that the market is ripe for correction following consecutive weeks of gains. Furthermore, market breadth declined to 0.64x (vs 2.25x the previous week) which resulted from more profit taking than bargain-hunting.
- We expect profit taking activity on tickers that have appreciated to persist as the hunt for dividend gradually dissipates.
- Barring any bargain hunting on bellwether tickers and corporate disclosures that may have significant impact on buying sentiments, we expect the market to close in the negative this week.
