For the week ended September 15th, 2023

- The bears took over the local bourse after three consecutive weeks of weekly gains. Specifically, the All-share Index shed 1.10% WoW to settle at 67,395.74pts. Thus, the Year-to-date return declined to 31.50%. Furthermore, market breadth waned further to 0.57x from 1.51x in the previous week.
- Across sectoral indices, performance was predominantly negative during the week. Of the seven sectoral indices under our tracking, only NGNINS (+0.46% WoW) and MERI-TELCO (+0.02% WoW) recorded weekly gain, while NGXBNK (-3.24% WoW), NGXCNSMRGDS (-1.84% WoW), NGXOILGAS (-2.02% WoW), NGXINDUSTR (-0.28% WoW), and MERI-AGRIC (-0.01% WoW) closed the week in the red zone.
- Also, OANDO (+42.86% WoW) topped the gainers' list while ABCTRANS (-33.63% WoW) led the laggards for the week. UBA was the most traded stock both by volume and value, during the week.

Market Preview

For the week commencing September 18th, 2023

- This week, we expect a rebound from the bulls in the local bourse. First, following the selloffs experienced last week, we posit that the relatively low stock prices present attractive entry opportunities for bargain-seeking investors.
- Additionally, it is expected that the recent nomination of a new CBN governor and management team should be seen as a positive signal for the market. Notably, banking tickers are likely to benefit significantly from this positive sentiment as investors view a change in leadership as an opportunity for fresh perspectives and policy direction that might benefit the sector.
- Nonetheless, the prevailing negative sentiment surrounding Nigeria's declassification by FTSE Russell could likely prompt further profit-taking activities on tickers that have appreciated.
- On a balance of factors, we expect the Nigerian equities market to close up this week.
