

#### Market Review For the week ended April 19<sup>th</sup>, 2024

- For the fifth consecutive week, the local bourse closed in the red zone, declining by 2.71% WoW. Thus, bringing the All-Share Index (NGXASI) down to 99,539.75 points. As a result, the Year-to-Date return fell to 33.12%.
- The week saw predominantly negative returns across sectoral indices. The NGXCNSMRGDS (-0.96%), NGXBNK (-11.46% WoW), NGXINS (-2.80% WoW), and NGXINDUSTR (-2.71% WoW) indices all closed in negative territory. On the other hand, the NGXOILGAS (0.00% WoW) remained flat while MERI-TELCO (+0.53% WoW) and MERI-AGRIC (+1.00% WoW) indices finished the week in the green zone.
- MORISON (+45.31% WoW) emerged as the highest gainer for the week, while LIVESTOCK (-18.99% WoW) experienced the most decline. ACCESSCORP and ZENITHBANK emerged as the most actively traded stock by volume and value, respectively.

### Market Preview

#### For the week commencing April 22<sup>nd</sup>, 2024

- We anticipate subdued activity in the Nigerian Equities Market this week as we foresee no significant triggers to stimulate buying interests during the week. We also expect continued profit-taking activities on certain tickers with elevated prices.
- Also, the Primary T-bills auction coupled with the tepid system liquidity might prompt a rotation of funds from the equities market given the attractive rates in the fixed income market.
- However, we do not rule out the possibilities of bargain hunting activities as investors taking position ahead of the release of Q1:2024 earnings results.
- Overall, we expect a bearish performance in the NGXASI next week.
